DEPOSITS & PAYMENT

A £30 deposit is required at the time of booking to secure the event between 8 -14 players.

A £60 deposit will be required at the time of booking for 15-30 players.

The remaining balance is due for 15-30 guest category 10 days prior to the date of the event. (this will be non-refundable, unless cancelled by Woodside Golf)

Remaining balance for 8-14 guests can be paid before or on the day of the party. The deposit and booking form confirms your booking.

The deposits are non-refundable unless cancelled by Woodside Golf. Deposit & final payments can be paid over the telephone 01477 532388

The deposit will be deducted from the final balance. If there are less participants than places reserved by the organiser those places will be chargeable. Final numbers 10 days before the event determines payment

owed. **For group bookings no individual payments. The organiser or a nominated person to pay the balance in one transaction.**

- No football boots permitted (**trainers only**)
- Balls **must not** be retrieved from the ponds
- The use of Footballs are **not permitted** in the car park or any other area other than the footgolf course
- Balls included (only balls belonging to Woodside can be used)
- The course is a working golf course therefore, if you hear the word "FORE" shouted this is a warning that a golf ball may be heading in your direction, please take cover or move out of the way.

- Please take notice of all other health & safety signage on the course

- Adults to make children aware of all safety rules

- Only food purchased at Woodside Golf can be consumed on the premises.

Trainers only. For the **mini-golf**-putters & balls will be supplied by Woodside golf.

Important Information: It is the full responsibility of parents/guardians to supervise children at all times. It is not possible for our staff to supervise children. Any requests from staff must be adhered to. Children are not to be left unaccompanied on the premises at any time.

1 parent/guardian per group of 4 children will be adequate supervision. Please remember that our main business is a golf course, it is imperative for health and safety reasons that any instructions from staff are adhered to, whether before or after the game. Please can all parents/coaches/carers/guardians ensure that participants do not play football in the garden or any other area, other than the footgolf course (Please DO NOT bring personal footballs) Please ensure that participants do not run round the car park or the driveway, onto the course and the premises in general or climb on any equipment or trees. The group must remain together at all times.

Please meet in the garden area at the back of the clubhouse. Organisers to report to reception. Football is only permitted on the footgolf course.

ALL customers using our facilities/car park do so at their own risk.

All guests are advised to wear trainers and suitable, loose fitting clothing. Football boots are not permitted on the course.

Footballs will be provided and must be returned to reception at the end of the session.

Foot Golf/Mini golf is an active sport and Woodside Golf (Leisurechain Ltd) cannot be held liable for any injuries caused during or after the party.

All children under 18 must be accompanied by an adult. It is the responsibility of the organiser in charge of the party, to ensure all children are adequately supervised.

The organiser will be responsible for the well being and behaviour of all children. The party organiser will be responsible for any damage caused by them or a member of their party

All children will be given a safety brief by a member of staff before they are permitted onto the course
